This Morgan Stanley China Privacy Policy ("Privacy Policy") covers the services offered in the People's Republic of China ("PRC") by Morgan Stanley entities located in PRC, that collect, hold, use, verify and disclose, etc. ("process") personal information as processors, including, but not limited to, Morgan Stanley Management Service (Shanghai) Limited, Morgan Stanley Bank International (China) Limited, Morgan Stanley Securities (China) Co., Ltd., Morgan Stanley Securities Investment (Beijing) Co., Ltd., Morgan Stanley Investment Management (China) Co., Ltd., Morgan Stanley Futures (China) Co., Ltd., Morgan Stanley (China) Private Equity Investment Management Co., Ltd., Morgan Stanley Overseas Investment Fund Management (Shanghai) Limited, Morgan Stanley Business Consulting (Shanghai) Limited, and the respective affiliates and branches in the PRC. Together, these entities are referred to as "Morgan Stanley," "our affiliates," "we," "us," and "our" in this Privacy Policy.

本《摩根士丹利中国隐私政策》（“隐私政策”）适用于由位于中华人民共和国境内（以下简称“中国境内”）的摩根士丹利实体在中国境内提供的服务。这些实体以处理者的身份收集、持有、使用、验证和披露等（“处理”）个人信息，这些实体包括但不限于：摩根士丹利管理服务（上海）有限公司、摩根士丹利国际银行（中国）有限公司、摩根士丹利证券（中国）有限公司、摩根士丹利证券投资（北京）有限公司、摩根士丹利基金管理（中国）有限公司、摩根士丹利期货（中国）有限公司、摩根士丹利（中国）私募股权投资管理有限公司、摩根士丹利海外投资基金管理（上海）有限公司、摩根士丹利商务咨询（上海）有限公司及其在中国境内的关联机构和分支机构。在本隐私政策中，这些实体统称为“摩根士丹利”、“我们的关联方”、“我们”或“我们的”。

We are committed to maintaining the privacy and confidentiality of your personal information. Morgan Stanley has a global framework to comply with applicable data protection and privacy laws, which includes policies and procedures that prescribe how Morgan Stanley personnel must process your personal information.

This information is required by law and is not a promotion of our products and services.

1. Information We Collect 我们收集的信息

As described in this Privacy Policy, we may collect personal information from or about you in order to provide, enhance, market, and offer our products and services, including the products and services of our Morgan Stanley affiliates (together, “**Services**”) to you and to our institutional clients. “Services” include, among other things, maintaining or servicing accounts, providing customer service, processing or fulfilling trades and other transactions, verifying customer information, processing payments, providing financing, determining eligibility for Services, recordkeeping, and related activities.

如本隐私政策所述，为了向您以及我们的机构客户提供、改进、营销并提供我们的产品和服务，包括我们摩根士丹利关联方的产品和服务（统称为“**服务**”），我们可能会收集您的个人信息或关于您的个人信息。“服务”包括但不限于提供或维护账户服务、提供客户服务、处理或完成交易及其他交易类活动、核实客户信息、处理付款、提供融资、确定服务资格、记录保存及相关活动。

This section describes the categories of personal information we may collect. The type of personal information we collect may vary depending on whether you deal with us as an individual or in connection with one of our corporate or institutional clients, your use of particular services, as well

as the jurisdiction where you reside. For purposes of this Privacy Policy, personal information generally includes information that may be used to identify you directly or indirectly. We may also request your sensitive personal information (as described in Section 4) for us to provide the Services. We only collect personal information in accordance with PRC applicable law, such as where we have your consents or necessary for compliance with a legal obligation or necessary for performance of a contract.

本条描述了我们可能会收集的个人信息类别。我们收集的个人信息类别可能因您是以个人身份与我们往来，还是以与我们的企业或机构客户相关联的身份与我们往来而有所不同。此外，我们收集的个人信息类别也可能因您使用的特定服务以及您居住的司法管辖区而不同。根据本隐私政策的目的，个人信息通常包括可直接或间接识别您身份的信息。为向您提供服务，我们可能还会要求您的敏感个人信息（详见第 4 条）。我们仅在符合中国适用法律的情况下收集个人信息，例如在获得您的同意时、为履行法定职责或法定义务所必需时或为履行合同所必需时。

You are not required to supply any of the personal information that we request. However, failure to supply any of the personal information that we request may result in our being unable to open or maintain your account, provide services to you or your company, discuss any other opportunities with you or deal with other matters.

4. Processing of Sensitive Personal Information

Sensitive personal information refers to personal information that, once leaked or illegally provided or misused, may harm personal or property safety and will easily lead to infringement of the personal reputation, human dignity, physical or psychological health, or discriminatory treatment. We only process sensitive personal information for purposes necessary if and to the extent permitted or required by applicable law such as performance of privacy impact assessment, and is not subject to use limitation rights under applicable law.

6. Monitoring We Conduct 我们采取的监测措施

To the extent permitted by applicable law, we, access, review, disclose, intercept, monitor and/or record (“**Monitor**”) (i) verbal and electronic messaging and communications (e.g., telephone,

facsimile, sms, instant message, email, and video conferencing and any other electronic or recordable communications) with you and your agent (“**Communications**”) and (ii) your use of technology owned by or made accessible by us, our associated firms or any other persons on our or their behalf, including but not limited to systems that facilitate Communications with you or your agent, information processing, transmission, storage and access, as well as remote access (collectively “**Systems**”).

8. Information on Minors Under 14 Years

不满 14 周岁未成年人个人信息

We pay particular attention to protection of the minors' personal information. Our services are not directed to or intended for individuals under 14 years of age. We do not knowingly collect information from individuals under the age of 14 years without parental consent. If we become aware that an individual under 14 years has provided us with personal information without parental consent, we will take steps to remove the data as permitted by law. For those personal information we collect with the consent of the parents or guardians, we will only process such information to the extent allowed by law and regulation or expressly consented by the parents or guardians or necessary for protection of the minors' interests.

9. Location of Data Storage and Processing

The personal information we collect from you will be stored in the PRC and may be stored in other countries or territories that may have different privacy laws and standards than those in your country of residence. Your personal information may be transferred to or processed in the PRC by us or by a third-party service provider working for us. If you are located outside of the PRC, the transfer of personal information is necessary to provide you with the requested information, products, and services and/or to perform any requested transaction. When we transfer or disclose your personal information to other countries or territories, we will protect that information as described in this Privacy Policy. By submitting personal information via our website or other means, you agree to such storage, transfers, and processing.

Morgan Stanley maintains appropriate physical, technical and procedural safeguards designed to protect any personal information from accidental or unauthorised loss, misuse, damage, modification, access or disclosure.

11. Retention of Personal Information

保存您的个人信息

We retain personal information in an identifiable form in accordance with our records retention policy which establishes general standards and procedures regarding the retention, handling and disposition of personal information. Personal information is retained as long as necessary to meet legal, regulatory, archival, accounting, auditing, reporting and business requirements. Retention will be extended if we are required to preserve personal information in connection with litigation, investigations and proceedings where required by applicable laws and regulations. For example, in accordance with *Administrative Measures for the Customer Identification Verification and Preservation of Customer Identification Material and Transaction Records of Financial Institutions*, and *Provisions on the Scope of Collection and Preservation Period in the Document Archiving of Enterprises*, the customer materials shall be kept up to 30 years or even longer, depending on the usage purpose and document nature of relevant material. Upon request, we and/or our associated firms will provide you with more information on the exact retention periods applying to your personal information in each case. After the retention period expires under relevant

data retention policy, we will destroy, delete or anonymize relevant information, or where the destruction, deletion or anonymization is not possible, store your personal information securely.

12. Marketing We Conduct

If there are any products or services that we or our associated firms believe may be of particular interest to you, whether provided by us, by our associated firms, we or our associated firms will contact you by mail, email, telephone, etc., including outside standard working hours or if you are travelling overseas. Where required by applicable law, we will request your prior consent before we or our associated firms use your personal information for marketing purposes. If you do not wish us to use or provide to our associated firms your personal information for marketing purposes, you may contact us as described in Section 15 any time or as directed in any marketing materials we send to you. Please note that if you do not wish us or our associated firms to contact you for such purposes, we or our associated firms may need to limit the range of products and services which we or our associated firms will offer to you.
